# TERMS & CONDITIONS

1. The term 'Organizers' shall mean Marriage Mantra Pvt. Ltd., having its registered office in Mumbai. The term 'Exhibitor' shall include all employees, staff and agents of any company, partnership firm or the individual to whom the space has been allocated for the purpose of participation.

2. ALLOCATION OF STALL: Subleasing of any part of the stall is strictly prohibited and illegal. One fascia will be displayed per stall. The display of goods shall be in accordance with that mentioned in the booking form. Any other products sold/displayed will be confiscated and the organizers reserve the right to close the entire stall and to claim monetary compensation in the case of defaulters.

3. PAYMENT TERMS: 50% payment should be made at the time of booking and a PDC of the balance payment dated two months prior to the show must be issued along with it.

4. BANK CHARGES: In the event of a cheque dishonored by the bank due to any reason, or in case of bank transfers, the charges applied by the bank (if any) will have to be borne by the exhibitor only.

5. STALL INTERIORS: All stall interiors and decoration should be completed one hour prior to the start time of the event. While the Exhibitors are free to decorate their stall, they should not cause any damage to the walls, panels and floors through use of nails, painting or any other such activity.

6. FORFEITURE AND RE-ALLOTMENT OF STALLS: If the total payment is not received within one week of booking the stall, the organizers reserve the right to cancel the booking and reallocate the stalls. In the event of cancellation for any reason, no refund of advance paid will be made under any circumstances. The amount paid will also not be carried forward towards other exhibitions.

7. POSSESSION OF STALLS: Possession of stall/space will be given only on receipt of full payment of stall fee and any extra charges.

8. MODIFICATIONS: Any changes in the stall structure, provision of facilities etc. are to be undertaken by the approved contractors only. External/Internal decorators are allowed to decorate the stall with written permission from the organizers. Any additional facilities and changes required in the stall can be co-ordinated by the organizers, which will be provided at extra cost. The request for the same should be given in writing in the appropriate forms to the organizers at least one month in advance. No alteration to the size or the position of the participant's stall can be made without prior written approval to the organizers. The exhibitor shall have no right whatsoever to use/block any area of the exhibition other than the area allocated to him. The organizers reserve the right to modify the layout of the stall, gangways and pathways etc. Entrance/Exit to The Marriage Mantra exhibitions is as per the layout. No equipment can be operated which emits excessive noise/smoke. The participants are requested to make sure that the fellow participants are not disturbed when using audio-video presentation. No banners etc will be allowed in the exhibition premises or on the roads in vicinity unless their design specifications, installation and location have been approved by the organizers, without which a penalty will be levied.

9. NON-OCCUPANCY: Every participant shall occupy the full stall area allotted to him. In case of non-occupancy of stall space, the organizers reserve the right to sell the stall/space (confiscate/reallot) and the amount paid stands forfeited. The participants shall not assign, subject or grant license in respect of the whole or a part of the stall. No cards, advertisements or printed matter of persons or firms who are not bonafide participants of this event may be presented or distributed from any stall.

10. SECURITY: The organizers will make general security arrangements during day and night. However, participants should take

all possible precautions and will be responsible for the security of their goods and stall displays. In case of an exhibition of over more one than day, the goods can be stored overnight within the exhibitors' respective stalls and the halls will be sealed overnight. No claims on theft/loss will be entertained by the organizers. Security arrangements are participant's responsibility; hence all the stalls and belongings are the responsibility of the exhibitor only.

11. BUSINESS LICENSE/TAX: It is the participant's responsibility to obtain necessary licenses for making any sales and transacting other businesses and pay taxes, levies, duties etc on their own. The organizers are not liable for any such taxes, levies, duties or consequential penalties as may be incurred by the exhibitor. It is the exhibitor's responsibility to be registered under Sec 16 of MVAT Act 2002. All exhibitors are required to carry their documents of registration under MVAT Act at the exhibition. Any tax liability arising under Sec of MVAT will be the sole responsibility of the exhibitors. The Organisers will in no way be held responsible for any tax liability arising out of the same.

12. INSURANCE: Participants will have to insure their exhibits, display materials against loss, damage, theft, fire, rain, cyclone & earthquake or any other causes, whatsoever. The organizers shall not be liable/responsible in any way for personal injuries and material damage of the exhibitor or his staff, agent invitees, or licensee and damages to the exhibits, however caused.

13. CONSEQUENTIAL LOSS: In case of the exhibition being cancelled or suspended in whole or in part for causes not in the organizers' control, the organizers do not accept any consequential liability in any such eventuality and refund will not be made under any circumstances. The organizers reserve the right to change the venue and dates of the exhibition without assigning any reason, whatsoever and refund will not be applicable in such cases.

14. The organizer will ensure supply of essential services at the venue. As the supply of such services is not within the control of the organizers, the organizers are not liable for any loss or damage. If any such service shall wholly/partly fail or ceases to be available, no refund will be made.

15. VIOLATION OF RULES: In the event of the violation of the rules or if the exhibitor indulges in activities against the guidelines, the organizers reserve the right to close down the stall of the participant immediately.

16. POSSESSION TIME: The confirmed space will be allocated to the participants at 8:00 am on the day of the exhibition. The Exhibitors Badges will be handed over 1 hour prior to the opening of the exhibition. All exhibitors are requested to kindly wear their badges at all times while in the exhibition premises for security reasons.

17. VACATION OF SPACE: The allotted space will have to be vacated by 21:00 hrs, on the day of the exhibition. No Material will be taken out of the premises without valid exit gate pass from the organizers which will be issued in the evening of the day of the exhibition. Any verbal agreement by the organizers concerning any aspect of this contract of the event is not valid unless confirmed in writing. The organizers shall have the right to make any changes or add any new clauses in the rules and regulations as they deem desirable.

18. Any commitment given by the personnel of the organizers must be mentioned on the booking form, otherwise the same will be deemed to be void.

19. DISPUTES: Any dispute between the organizers and the participant is subject to jurisdiction of the courts of Mumbai city only.
